STANDARD BID CONDITIONS

1. BACKGROUND AND PRICES

- 1.1 In terms of the National Treasury Supply Chain Management- a guide for Accounting Officers/Authorities 2004, where goods, services or works of a technical/specialized nature are required on a recurring basis, a framework database of approved suppliers for the supply of the goods, services or works may be established. The database should be established through a competitive bidding process.
- 1.2 Once the framework databases of suppliers for the five districts have been established and approved by the Accounting Officer, only the service providers included in the framework database can be approached to quote for routes according to capacity.
- 1.3 The framework database will assist as routes and number of children are changing annually, which is problematic when a service provider is appointed for a three year period.
- 1.4 Bids will be evaluated on the qualification criteria to qualify for the next stage of B-BBEE status, of which bidders will only be evaluated on BBEE level of contribution for them to be placed on the panel of framework contractors.
- 1.5 Bidders who qualify with all criteria will be appointed on the panel/framework/database and will then be invited and evaluated further on the 90/10 Preference Point System for price and BBEE contribution on the quotations for routes.
- 1.6 90 points for Price will only be evaluated as and when quotations are issued for routes.
- 1.7 Standardised maximum tariffs per km will be applicable as follows:

Mini bus (10 to 16 seater) = R22-75
Midi bus (17 to 35 seater) = R26-39
Bus (35 seater upwards) = R27-59

2. COMPLETION OF BID DOCUMENT

A. STANDARD BID DOCUMENTATION FORMS (SBD) TO BE COMPLETED AND SIGNED

- 2.1 **SBD 1:**
The **SBD 1** bid invitation form to be completed in full and signed.
- 2.2 **SBD 4:**
The declaration of interest form (SBD 4) to be completed at all times (if applicable or not) and signed by the bidder. The service providers must declare any relationship with any person employed by the Department as contemplated in the National Treasury Practice Note no 7 of 2009/2010 (SCM – Declaration of Interest). Failure by the service provider to declare relationships and connections as stipulated in paragraphs 2.7 to 2.11 of the SBD 4 form will result in an immediate termination of the bid/contract. Failure to complete and sign may disqualify your offer.
- 2.3 **SBD 8:**
The Declaration of Bidder's past Supply Chain Management Practices (SBD 8) form to be completed and signed. Failure to complete and sign the form may disqualify your offer.



2.4 SBD 9:

The Certificate of Independent Bid Determination (**SBD 9**) to be completed and signed. Failure to complete and sign the form may disqualify your offer.

B. CORRECTION FLUID AND CORRECTIONS TO SBD FORMS

2.5 Correction fluid (e.g. Tippex) must not be used in bid documents in order to correct mistakes.

2.6 Where a bidder wishes to correct a mistake, a single line must be drawn through it and the bidder must place his/her signature and date next to the correction, so that the original entry is still visible and legible.

2.7 In the case of alterations/corrections a full signature must be attached above, next to or below the said alteration or correction

C. BID FORMS

2.8 The bid forms should not be retyped or redrafted.

2.9 Only the bid documents issued by the Department of Education Free State must be used.

2.10 Bid documents to be completed in full.

2.11 Bidders shall check the numbers of the pages and satisfy themselves that none are missing, duplicated or misprinted. No liability shall be accepted in regard to claims arising from the fact that pages are missing, duplicated or misprinted.

D. SUBMITTING OF BID DOCUMENTATION

2.12 Unless specifically provided for in the bid document, no bid transmitted by telegram, telex, facsimile or similar apparatus shall be considered.

3. FORMS TO CLAIM POINTS FOR B-BBEE (SBD 6.1 FORM)

- 3.1 Where points are claimed for B-BBEE Status Level of Contribution the SBD 6.1 form, to be completed in full and signed by the bidder. A **VALID AND ORIGINAL/ORIGINAL CERTIFIED BBEE** Status Level Verification Certificate should be attached.
- 3.2 BBEE Status Level Verification Certificates should be issued by the agencies as stipulated in Par 5.4 of the Standard conditions.
- 3.3 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 3.4 A **trust, consortium or joint venture** will qualify for points for their B-BBEE status level as an Unincorporated entity, provided that the entity submits their **consolidated B-BBEE scorecard** as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

5. BID EVALUATION/ADJUDICATION CRITERIA (PRICE AND B-BBEE) (PRICE ONLY APPLICABLE WHEN QUOTATIONS IS ISSUED TO APPOINTED SERVICE PROVIDERS ON THE PANEL)

- 5.1 Bids will be evaluated in terms of the new Preferential Procurement Regulation, 2017 Regulation 3(a)(ii) "if it is unclear which preference point system will be applicable, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system.

The following formula will be used to calculate the points for price:

$$P_s = 80/90 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration

P_{\min} = Comparative price of lowest acceptable bid

- 5.2 Points will be allocated to a Bidder for attaining their B-BBEE status level of contributor in accordance with the table below:

- 5.3 Bidders are required to complete the preference claim form (SBD 6.1), and submit a valid **ORIGINAL/ORIGINAL CERTIFIED BBEE** verification certificate issued by a verification agency accredited by the South African Accreditation System (SANAS) or a or a valid sworn affidavit signed by the EME/QSE representative and attested by a commissioner of oath.
- 5.4 Bidders must ensure that the B-BBEE status level verification certificates submitted are issued by the following agencies:
- (i) Tenderers other than EME/QSEs: Verification agencies accredited by SANAS, or
 - (ii) Tenderers who qualify as EME/QSEs: Sworn affidavit signed by the EME/QSE representative and attested by a Commissioner of oaths.
- 5.5 Verification agencies accredited by SANAS are identifiable by a SANAS logo and a unique BVA number.
- 5.6 Only Bidders who have completed and signed the declaration part of the preference claim form and who have submitted a B-BBEE verification certificate issued by a verification agency accredited by the South African Accreditation System (SANAS) or valid sworn affidavit signed by the EME/QSE representative and attested by a Commissioner of oath will be considered for preference points.
- 5.7 Failure on the part of the Bidder to comply with the above paragraphs will be deemed that preference points for B-BBEE status level of contribution are not claimed and will therefore be allocated a zero (0).
- 5.8 In the event that two or more bids have scored equal total points, the contract will be awarded to the Bidder scoring the highest number of preference points for B-BBEE.
- 5.9 However, when functionality is part of the evaluation process and two or more Bidders have scored equal points including equal preference points for B-BBEE, the contract will be awarded to the Bidder scoring the highest for functionality.
 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.
- 5.10 A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.



**6. BID PRE-QUALIFICATION CRITERIA FOR PREFERENTIAL PROCUREMENT
(DEFINED IN THE PREFERENTIAL PROCUREMENT REGULATIONS, 2017):**

(PHASE 1: PRE-EVALUATION)

6.1 Only bidders with BBBEE level 1-3 will qualify.

Conditions on BBBEE level:

- If the level is not indicated on your certificate/affidavit your offer will be disqualified.
- If the BBBEE certificate/sworn affidavit is not signed your offer will be disqualified.
- If the BBBEE certificate/sworn affidavit level is not between 1-3 your offer will be disqualified.
- If the BBBEE certificate/sworn affidavit is not valid (expired) your offer will be disqualified.
- If an original certified/original BBBEE certificate/sworn affidavit is not attached your offer will be disqualified.

In case of a Joint Venture a consolidated B-BBEE certificate/sworn affidavit for the Joint venture company should be submitted. Please note if BEE certificates/sworn affidavits for each company is submitted and not a consolidated B-BBEE certificate your offer will be disqualified as proof of the correct BBBEE level for the JV cannot be determined. The consolidated B-BBEE certificate/affidavit should comply with the requirements as mentioned in above bullets.

6.2 (PHASE 2 : FUNCTIONALITY)

The bidders will be assessed for the pre-qualification as set out in functionality criteria. Failure to comply with the requirements will lead to points being forfeited. Bidders scoring less than the minimum score of **21 points** for functionality criteria will automatically be disqualified:

7. JOINT VENTURE AGREEMENT (COMPULSORY IF APPLICABLE)

- 7.1 In the event that a joint venture bid is submitted, a joint venture agreement, witnessed by a registered Attorney at Law must be submitted with the bidding document.
- 7.2 **Failure to submit a Joint Venture agreement that are signed by all the parties in the Joint Venture** will render the bid non-responsive and your offer will be disqualified.

8. PAYMENT TO SUPPLIERS

Payments will be handled as prescribed by the PFMA and will normally be effected within 30 days of receipt of all the required documentation, which should be correct in every respect.

9. LEGISLATION / LAWS

Bidders must comply with the provisions of Labour Legislation as well as any other relevant legislation or legal requirement.



10. VALIDITY PERIOD OF BID

The period for which offers are to remain valid and binding (in order for the Department to finalize it), is indicated in the bid documents (**120 DAYS**) and is calculated from the closing time on the understanding that offers are to remain in force and binding until the close of business on the last day of the period calculated and if this day falls on a Saturday, Sunday or public holiday, the bid is to remain valid and binding until the close of business on the following working day.

11. QUANTITIES

Where quantities are specified in the bid documents the Department cannot guarantee that they will be ordered as such, as it depends on Departmental needs. The Department is not liable for any damages the contractor might suffer for not ordering specific quantities.

Where quantities are specified, "as required" the quantities will be ordered as and when needed.

12. SPECIFICATION – BIDDERS RESPONSE

Where a specification provides for the bidders response to the different points of specification, the form must be properly completed. Where items deviate from the requirement, the deviation must be indicated.

13. QUALIFICATIONS OF BIDDERS

13.1 The Accounting Officer does not bind himself/herself to accept either the offer scoring the highest point or any bid and reserves the right to accept or cancel the bid which he/she deems to be in the best interest of the Department even if it implies a waiver by the Accounting Officer of certain bid requirements which the Accounting Officer considers to be of minor importance and not complied with by a bidder.

13.2 The department will disqualify any bid from a bidder whose name appears on the national list of restricted bidders/suppliers/persons.

13.3 The department may terminate the contract in whole or in part if the supplier and/or representatives of the department, in the judgement of the department, committed or have engaged in corrupt or fraudulent practices during the bidding process or the execution of that contract that benefited that supplier.

13.4 The Department reserves the right to allocate a bid to different service providers to ensure the empowering of as many companies as possible.

14. COMPLIANCE TO CONTRACT

14.1 The Department may monitor compliance to the contract after adjudication of the bid that include, but need not be limited to, site inspections and the request for documentary proof of compliance with the PFMA and relevant legislation.

14.2 Where services are rendered, which involves minimum wages for employees in terms of the sectoral wage determination, the Department reserves the right to request copies of payslips of employees during the period of the contract.

- Restrict the contractor, its shareholders and directors from obtaining business from any organ of state for a period not exceeding 10 years.

19. SUCCESSFUL BIDDERS

The specification for the Framework is as follows:

1.1 Period of Framework

The period for the framework database is from date of approval for three years.

1.2 BBBEE level pre-qualification criteria

Only bidders with BBBEE level **1 to 3** will qualify

1.3 General Conditions

- Applicants must be aware that all appointments will be made at costs not exceeding the approved standard rate.
- Standardized maximum tariffs will be applicable as follows:
 - Minibus (10-16 seater) = R22-75 per km
 - Midi bus (17–35 seater) = R26-39 per km
 - Bus (35 seater upwards) = R27-59 per km
- Bidders appointed on the Framework will be requested to submit quotations equal to or lower than the above rates.
- No price adjustments will be allowed during the 1st year of the contract period, it will only be considered using a 5% increment annually from date of appointment.
- Operators applying for the bid should be registered for Public Transport within the Free State and vehicles included in the bid will be verified against the NATIS system. Attach a letter that confirms this from DPRT and the Registration Administration System Number (RAS Nr).
- In case of suspected fraudulent documentation, relevant action will be taken.
- Non-compulsory briefing sessions will be held in clusters in each district.
- It is preferred that Service Providers **only** bid in the District where they reside. Service Providers will be allowed to indicate their willingness to assist the Department in ONE other district, should the need arise to appoint service providers outside the districts that they reside in.
- The department reserves the right to utilize service providers appointed in the framework bid of a specific district in other districts should the need arise because of vehicle/capacity shortages.

1.5 Compulsory documents

1.6 Delivery of service

- 1.6.1 Safety is of paramount importance in the transportation of learners to and from school each day. The Operator must ensure that safe and reliable services are provided. This means the Operator must deliver a reliable service with drivers and vehicles that comply with all licensing and regulatory requirements and are well maintained, to ensure learners arrive at school on time and ready to learn.
- 1.6.3 The Operator must comply with and strictly adhere to the Department's official general contract (as attached) and/or its Authorised Representative's instructions and directions regarding the operation of the services.
- 1.6.4 The Operator shall ensure that all staff (employed or contracted) have a valid Public Driver's Permit (PDP), always treat learners with respect and courtesy, and all reasonable assistance is offered to facilitate the safe travel of a learner.
- 1.6.5 The Operator will ensure policies are in place advising staff (employed or contracted) and subcontractors of their obligation to act in a professional manner at all times when acting in relation to this contract and delivering any of the services provided under it and will have systems to deal with breaches to these policies.
- 1.6.6 Only stops/pick up points authorised by the Department and/or its Authorised Representative are to be used by the Operator.
- 1.6.7 The performance of the service by the Operator shall be observed, monitored and inspected by the Department or its Authorised Representative at its own discretion for compliance with this Contract.
- 1.6.8 In addition to any statutory obligations, the Operator must, within twelve (12) hours of its occurrence, report to the Department any accident in which persons have been injured or killed. This must be followed by a written report containing full details of the occurrence within four (4) weekdays of the occurrence.
- 1.6.9 Unless agreed to in writing by the Department, cancellation of scheduled trips is not permitted unless—
- (a) instructed by the Department on the basis of insufficient programme funds as budgeted for in the Provincial budget;
 - (i) Notification of service suspensions or reduction must be made at least 30 calendar days before the suspension or service reduction is to come into effect
 - (b) requested by the Operator and agreed to in writing by the Department
- 1.6.10 Actual route distances as agreed between the Operator and the Department shall be used to calculate revenue kilometres for each trip, provided always that the onus is on the



Operator to prove that trips have been operated. The Operator will not be paid for positioning kilometres.

1.6.11 The Department or its Authorised Representative may after consultation with the Operator recommend the following variations to the services within the service area, but the prior written consent of the Department is mandatory before any variation is effected:

- (a) to increase or decrease the number of scheduled trips on any route or routes;
- (b) to omit any route or add a new route;
- (c) to lengthen, shorten or alter an existing route, where "alter" means to change the route without increasing or decreasing the kilometre length thereof;
- (d) to alter the number or location of authorised pickup points, in consultation with the relevant local authority/administration/community/school and/or traffic authority where applicable; and
- (e) to change the time table of any portion of the services;
- (f) to make alterations in connection with vehicle capacities

1.6.12 Prohibition of Restrictive practices

- a) In terms of Section 4 (1) (b) (iii) of the Competition Act No.89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is /are or a contractor (s) was/were involved in collusive bidding (or bid rigging).
- b) If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has/have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No.89 of 1998.
- c) If a bidder(s) or contractor(s), has/have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and/or terminate the contract in whole or part, and/or restrict the bidder(s) or contractor (s) from conducting business with the public sector for a period not exceeding ten (10) years and/or claim damages from the bidder(s) or contractor(s) concerned.

1.6.13 Inspections

- a) All pre-bidding testing will be for the account of the bidder.
- b) It is a bid condition that vehicles can be expected at any stage to be subject to inspection, at all reasonable hours, by a representative of the Department or an organization acting on behalf of the Department.
- c) If required to during the contract period, continued inspections shall be carried out.
- d) Where there is non-compliance to clauses 2 and 3 and with the contract requirements, this may lead to rejection of relevant vehicles.
