In case of a Joint Venture a consolidated B-BBEE certificate for the Joint venture company should be submitted.</p> <p><b>BID PRE-QUALIFICATION CRITERIA FOR PREFERENTIAL PROCUREMENT (DEFINED IN THE PREFERENTIAL PROCUREMENT REGULATIONS, 2017):</b> Only tenderers having B-BBEE status level of contributor <b>1-3</b> will be considered.
